



MINUTES
VIRTUAL ORDINARY GENERAL ASSEMBLY OF ISCO3
(Art. 20 statutes)
March 22, 2020

Nota Bene: The minutes were sent to ISCO3 members on March 24, 2020. As no objection was indicated by any ISCO3 member on March 26, 2020 the minutes have been unanimously approved.

In accordance with Article 20 of the statutes it was convened a Virtual Ordinary General Assembly of ISCO3 on March 15, 2020 to approve the third of the Madrid Declaration on Ozone Therapy. Two previous drafts had been sent to ISCO3 members for discussion.

The deadline to vote in favor of or against the third draft of the Madrid Declaration on Ozone Therapy ended on March 22, 2020.

The results are:

Total members of ISCO3: 27

Total members of ISCO3 with the right to vote: 27

Total votes cast: 26.

Total votes in favor of the third draft paper: 26.

Total votes against the third draft paper: 0.

One member did not vote and did not give reasons for his non-participation in this mandatory voting process:

Francisco Ubiratan Ferreira de Campos.

As per article 21 of the ISCO3'S by-laws, "a qualified majority of the members present or represented in the voting, this being the two-thirds of such members, shall be necessary to approve a new edition of the Madrid Declaration on Ozone Therapy." So as 26 members participated in the voting and 26 voted in favor, the third draft of the "Madrid Declaration on Ozone Therapy" has been approved unanimously by ISCO3 on March 22, 2020, because there was no vote against.

As Wayne Wayne, member of the committee, took the responsibility to review the

English wording and he did it from the very beginning with the first and second drafts, and in addition, several members, also made corrections to the English wording, the draft committee has considered that it is no longer necessary another revision.

So the committee will start the process of translating into Spanish; and of printing. It would take longer than expected due to the limited conditions that the editorial industry has been obliged to implement.

The drafting committee (Adriana Schwartz and Gregorio Martínez) took the opportunity to thank the members of ISCO3 that put time aside to participate actively during the updating process of the Declaration, that actually started in July last year. The drafting committee consider that the result has been a teamwork that reflects the spirit of our committee: provide guidelines that are the result of exchanges of knowledge, expertise, opinions, and views of everybody of the committee.
