

MINUTES VIRTUAL EXTRAORDINAY GENERAL ASSEMBLY OF ISCO3

(Art. 20 statutes) February 25, 2023

Nota Bene: The minutes were sent to ISCO3 members on February 28, 2023. As no objection was indicated by any ISCO3 member on March 3, 2023 the latest, the minutes have been unanimously approved.

A. In accordance with Article 20 of the statutes it was convened a Virtual Extraordinary General Assembly of ISCO3 to decide on the expulsion of members who have not pay their annual fees, to approve the 2020-2022 budget, and to approve the forecast 2023 budget.

Preliminary considerations

- B. The Governing Body (Statement, Dec 8, 2022) "kindly requested" seven members "to proceed to pay the amount owed no later than December 31, 2022. In case of not doing so, we will find ourselves in the painful obligation to initiate the expulsion procedure." Three reminders asking for the payment were sent by WhatsApp: Dec. 13, 27, and 31, 2022.
- C. It was decided (Feb 9, 2023) "to start the expulsion procedure for" six members, and "to convene a virtual extraordinary general assembly on Saturday February 25, 2023. It was clearly stated thar "those non-payers who decide to pay their dues, including the 2023 annual fees, before the day of the virtual extraordinary general assembly, their names will not be submitted for expulsion."
- **D.** The agenda for the virtual extraordinary general assembly was sent on February 16, 2023, which included a self-explanatory ballot paper for casting the votes.

- H. The by-laws states that "a qualified majority of the members present or represented in the voting, this being the votes of more than half of such members, shall be necessary to: (...) 3) Decide on the expulsion of a member", so a majority of nine votes was required to approve the expulsions.
- I. As all the candidates for expulsion received more than nine votes, the following persons are no longer members of the association:

- J. Francisco Ferreira de Campos, Carlos Goes Nogales, and Magda Siqueira informed that they had decided to resign. However, their resignations arrived to the secretariat during the election day or the day after. So, it was too late to withdraw their names from the ballot paper votes.
- K. The 2020-2022 budget was approved by 15 votes.
- L. The 2023 budget was approved by 15 votes.
